**1. “Schedule ‘A:’ Land Use (North Section)” to the County of Bruce Official Plan is amended by establishing site-specific policy area on part of the lands described as Concession 2, Lot3 (Amabel) Town of South Bruce Peninsula.**

**2. The following is added to Section 5.5.13 (Exceptions - Agricultural Areas)**

**5.5.13.71**

**Notwithstanding the policies of Section 5.5.4 [Permitted Uses - Agricultural Areas] of this plan, the lands described as Lot 3, Concession 2 (Amabel) Town of South Bruce Peninsula, and identified as Site Specific Policy Area 5.5.13.71 on Schedule ‘A’: Land Use may be used for a Contractors Yard, Automobile Service Station, and Auto Body Shop. All other policies of the plan shall apply.**
