## 4. Rural Economic Development Program

In September 2013, staff brought forward a report to the Committee that requested the authorization to apply to the Rural Economic Development (RED) fund for Spruce the Bruce. In February, we learned that we had been successful in that application although at that point it was still confidential. As of last Thursday, the Province publicly announced the funding for these two projects as well as several others in Bruce County.

## **Rural Business Recruitment and Enhancement Strategy**

The Municipality of Kincardine and the Town of South Bruce Peninsula will be participating in the project. Phase 1 will begin with data collection and analysis of the downtown economies of Wiarton and Kincardine, including visitor needs, spending patterns and trends. Staff will work with the Treasury department to develop an RFP process to secure a contractor to collect and analyze the data.

Phase 2 will consist of developing the Strategic Business Recruitment and Enhancement Tools. Phase 3 is informing and educating others on the study's findings and the benefits of evidence based strategic planning.

Total Grant Request \$155,000 County Contribution \$47,500 Municipal Contribution \$30,000 RED Contribution \$77,500

# **Destination Downtown: Brand Development Project**

The Municipalities of Kincardine, Saugeen Shores, and Northern Bruce Peninsula and the Town of South Bruce Peninsula will be participating in the Brand Development Project.

This Project will have 3 Phases which include 1) Education awareness; 2) Brand based Marketing Plan & Campaign Development; and 3) the implementation of created Collateral. These three sections will be part of a coordinated approach to marketing Bruce County downtowns as distinct destinations.
