A. Bruce County Official Plan Amendment No. 204

Subsection 4.3.1(xv) is modified by deleting the word 'wind', between 'Encourage the use of alternate energy sources, such as' and 'solar, biomass and hydroelectric';

Subsection 4.11(viii) is modified by deleting the words 'and wind', between 'Incorporating district heating, solar' and 'energy and similar designs into residential, commercial, institutional and industrial development'.

Notwithstanding the policies of Section 6.5.3.3 (Consents-Agricultural Areas) of this plan, the lands described as Part Lot 27, Concession 13 (Elderslie), Municipality of Arran Elderslie, and identified as Site Specific Policy Area 5.5.13.63 on Schedule 'A': Land Use may be severed into more than two parts to yield a maximum of 3 non-farm lots. All other policies of Section 6.5.3 (Land Division Policies) apply.
