The West Road Report including the payment of external engineering fees in the amount of approximately \$8,000 was received for information.

- A. Bruce Road 20, Budget Transfer

Moved by Councillor Milt McIver Seconded by Warden Mitch Twolan

That 2015 budget expenditures for Bruce Road 20 sections as outlined below be increased as follows:

Bruce Road 20A, CR15 south 1.5km \$ 70,000 Bruce Road 20B, CR 15 to CR 1, 4.7km \$ 120,000 Bruce Road 20C, CR 1 north 6.2km \$ 130,000 and,

That 2015 funds originally allocated to the West Road be reallocated to:

Bruce Road 20 as follows: Bruce Road 20A, CR15 south 1.5km \$ 70,000 Bruce Road 20B, CR 15 to CR 1, 4.7km \$ 70,000 Bruce Road 20C, CR 1 north 6.2km \$130,000 and,

That the Gas Tax Funding and the expenditures in the amount of \$50,000 for Bruce Road 6East C be reallocated to Bruce Road 20.
