# A. Grey Bruce Invest Program

Mr. David Smith, Senior Planner presented two videos from businesses participating in the Grey Bruce Invest Program.

Ms. Kim Clarke, Tourism Coordinator presented the Open Data Contest Winners Report.

# C. Forestry / Weed Update

Mr. Ken Goldsmith, Forestry Technician provided a forestry update to the Committee and reported that Emerald Ash Borer has been identified in Ripley, Lucknow and Southampton. Mr. Goldsmith also commented on noxious weeds including giant hogweed.

At the conclusion of his presentation, Mr. Goldsmith announced his retirement.

# 4. Delegations

# A. Bruce County Rail Trail

Mr. Alex Eveleigh made a presentation to the Committee requesting a change to the usage for the Bruce County Rail Trail to include dirt bikes.

The Committee responded by suggesting that prior to moving forward with this request, that a written submission be received from at least one of the local clubs indicating their support and willingness to include insurance coverage for this initiative.

# B. Grey Bruce Alternative Land Use Services (ALUS)

Mr. Keith Reid, Project Coordinator of the Grey Bruce Alternative Land Use Services made a presentation to the Committee on ALUS pilot projects which relate to a clean water program and includes:

- Wetland creation;
- Native grasses;
- Exclusion fencing;
- Pollinator hedgerow

ALUS has a simple yet revolutionary goal... to create a healthy working landscape that sustains agriculture, wildlife and natural spaces for all Canadians.

It was noted that this is a clean water program the County may wish to consider contributing to.

A. Town of Saugeen Shores Local Official Plan Amendment

B. Town of South Bruce Peninsula Official Plan Amendment

That the request for the County of Bruce to utilize the "Resource Constraint Model Evaluation Criteria" as presented for determining which lands would be excluded from a Mineral Resource Area as a pilot methodology, be approved.

Staff provided a summary of Issues Report Number 5 – Environmental Hazard Policies. The Committee discussed: the sources of mapping for the "Environmental Hazard" designation in the Bruce County Official Plan, the "local wetlands" shown on the constraint schedule, the "Woodlands" polices in the Bruce County Official Plan, as well as the "Significant Woodlands"

# Moved by Councillor Paul Eagleson Seconded by Councillor Bill Goetz

That staff provide an official plan amendment that modifies the existing Bruce County Official Plan, as well as land use and constraint schedules' by eliminating reference to "locally significant wetlands."

#### Carried

Councillor Larry Kraemer identified local concerns related to the reference to the woodland layer in the Municipality of Kincardine's Local Official Plan.

Staff advised that the modification or removal of the significant woodland constraint layer is within the prevue of Kincardine Council

# Moved by Warden John Close Seconded by Councilor Bill Goetz

That should the Council of the Municipality of Kincardine desire to modify or remove polices or mapping related to woodlands within the Kincardine plan area, that they pass a resolution to this effect, and undertake an amendment to their local plan; and,

That, following receipt of the resolution, Council County would review the merits of such amendments should a request for approval be made by Kincardine Council.
