- A. 2014 Federal Gas Tax Increased Funding

That the additional Federal Gas Tax surplus Association of Municipalities of Ontario administration money in the amount of \$52,450 be applied to the following 2014 Gas Tax project:

• Bruce Road Section 1F, North Limits of Kinlough to Kings Highway 9, which will increase the gross expenditure for this road section to \$332,450.
