5.5.13.66 - Notwithstanding the policies of Section 5.5 (Agricultural Areas) and Section 6.5.3.3 (Consents - Agricultural Areas) of this Plan, the lands described as Site Specific Policy Area 5.5.13.66 on Schedule 'A' Land Use Plan [Part of Lot 56, Concession 1 (being Part 1 of 3R-8040 and Part 1 of 3R-4222), geographic Township of Brant] may be severed to a maximum size of 2.04 hectares excepting however the severed lands shall be merged on title with an abutting lot. All other policies of Section 6.5.3 [Land Division Policies] shall apply.
