A. 210 Old Durham Road, Walkerton Mortgage Renewal 2016

That the Ministry of Municipal Affairs and Housing (MMAH) arrange on behalf of Bruce County Housing Corporation (BCHC) a refinancing of the existing charge/mortgage of land for its project municipally known as 920 Old Durham Road, Walkerton maturing on February 1, 2016 in the approximate amount of \$1,636,457.15; and

That the Housing Services Manager be authorized to sign the attached resolution on behalf of the Board of Directors of BCHC; and

That should there be a savings in the 2016 operational budget due to the refinancing of the existing mortgage that the savings be redirected to the capital reserve account for BCHC.

B. 2016 Market Rent Increase - Social Housing Units

That the rent for Bruce County Housing Corporation, social housing units be increased by the Ontario 2016 Rent Increase Guideline of 2% as indicated in the Bruce County Housing Corporation Market Rents April 1, 2016 except,

That the following units: 539 Ivings Drive, one bedroom (lower) and three bedroom; Queen St., Kincardine Ave., and Alice St., three bedroom townhouse; 535 Walter Street, 308 John St.; 920 Durham Road, three, and four bedroom; 403 Mary St. & 409 McNab Street, four bedroom; 4th St., and 2nd St.; and Hwy 6 be increased as indicated in the Bruce County Housing Corporation Market Rents April 1, 2016. Posted rents are based on the Average Market Rent or the Ministry of Municipal Affairs and Housing minimum recommended increase; and

That rent geared to income assistance be provided immediately for all tenants that qualify for rent geared to income assistance that may currently be paying the market rent but due to the increase in the Market Rent they would now qualify for rent geared to income assistance.
